**Denison Street, Camperdown (at Kilner Lane) –
Proposed Kerb Blister and Kerb Ramp
(Have Your Say)**

Council is planning to improve safety for pedestrians and other road users in Denison Street, Camperdown at its intersection with Kilner Lane by constructing a kerb blister and two kerb ramps. The works aim to improve pedestrian safety by better defining pedestrian crossing points and reducing the crossing width.

The Plan

The following works are proposed and illustrated on the attached plans.

Denison Street, Camperdown (Plan No. 10273):

- Construct landscaped kerb blister island with integrated kerb ramp and heel safe grating in Denison Street at its intersection with Kilner Lane,
- Construct two new concrete kerb ramps,
- Resurface the road pavement with new asphalt within crossing area (subject to final funding allocations);
- Provide new “Chevron Arrow” in Denison Street to warn motorists/drivers about proposed narrow section of the Road (near Kilner Lane)
- Install associated pavement edge line marking (to define parking spaces).

Please refer to the attached Consultation Plan (Plan No.10273), which illustrates the proposed works.

Parking changes

This proposal does not change any of the existing parking arrangements in Denison Street, and Kilner Lane as the works are contained to be generally within the statutory 10m No Stopping areas from the intersection. Therefore, there will be NO LOSS of parking spaces resulting from the proposed works.

Streetlighting

The existing street lighting at the location is deemed adequate. Therefore, no changes are proposed to the existing street lighting due to the works.

Please note however that Ausgrid is progressively replacing all existing streetlights throughout the Local Government area with new energy efficient and environmentally friendly LED streetlights, and this will be completed independent of this project.

What happens next?

Council has not yet made any commitment to change the traffic and parking arrangements in the street. A report, together with the community's comments and this proposal, will be considered by Council's Local Traffic Committee (LTC) at its meeting on Monday 18 March 2024. The Committee will make recommendations for Council to consider at the Council meeting on Tuesday 9 April 2024. You can check Council's determination shortly thereafter.

Council will notify everyone who provided comments of the final decision.

The LTC meeting agenda will be available to view on Council's website in the week before the meeting at www.innerwest.nsw.gov.au/council/meetings/committees/local-traffic-committee. Members of the public may register to speak at this meeting. Please note that COVID restrictions may apply and limit personal attendance to the Traffic Committee (subject to restrictions in place).

When is the work planned?

These works are expected to be undertaken during in 2023/2024 year, subject to the outcome of this community engagement, final approvals, and budget allocations. No firm construction date is yet available, and residents will be notified further before any work starts in the street.
