**Improving Stormwater Drainage in Dudley Street, Haberfield
(Generally In front of No.50 to No.52)**

Council is planning drainage improvement works in Dudley Street, Haberfield to better manage stormwater in this area by reconstructing kerb & gutter around the existing in-road tree pits.

The Plan

The following works are proposed and are illustrated on the attached plans.

Dudley Street (No.50 to No.52): Haberfield (Plan 10252-2)

- Remove the existing gutter / kerb & gutter in front of No. 50 & 52 Dudley Street;
- Trim any surface tree roots to provide required clearances for the new works;
- Construct new concrete gutter / kerb & gutter in front of No. 50 & 52 Dudley Street along the same alignment;
- Reconstruct the driveway to No.50 Dudley Street (due to the slight level change required by new gutter works);
- Reconstruct the layback section only of the driveway to No. 52 Dudley Street to accommodate the slightly changed gutter levels;
- Open up / lengthen the tree pits around the 2 existing street trees in front of No. 50 & 52 Dudley Street, provide new timber edging and ground cover landscaping with mulch.

Please refer to the attached Plans (Plan No. 10252-2) for more specific details and the extent of the proposed works.

Parking Changes

The proposed works does not change any of the existing parking arrangements in the street (except of a temporary basis during any construction activities). Therefore, there will be NO LOSS of parking spaces resulting from the proposed works after they are completed.

Council will consider any comments received before progressing design plans towards finalisation for the proposed works.


When is the work planned?
