Half-yearly update from the Chief Executive Officer



In my first report on the state of play at Inner West since joining Council in February 2019, I detail Council's achievements against the 2018/19 Operational Plan.

Operations

Inner West Council is one of Sydney's largest local governments, looking after a vibrant community of over 190,000 people living in some of the inner city's most vibrant, creative, liveable and diverse suburbs across the

five wards of Ashfield, Balmain, Leichhardt, Marrickville, and Stanmore. The Council area spans 36km^2 from the banks of Parramatta River at Birchgrove in the north east, to the Cooks River at Dulwich Hill in the south west.

Council delivers a wide range of essential and established services to the people of the Inner West, the scale and scope of which could surprise many people.

The following are just some:

- Manages assets with a total replacement value of \$1,783,959,000 or \$9,290 per resident
- Maintains 346km of local roads, 40km of regional roads, 77.4km of laneways and 845km of footpaths
- Maintains 27 sportsgrounds, 310 parks and 62 public toilet buildings
- Provides 31 rooms available for hire
- Maintains 7.7km of seawall along 17km of harbour frontage
- Provides eight libraries with 1,015,838 visits a year and over one million library items borrowed
- Provides five aguatic centres with 1,540,000 visits a year
- Provides or supports 645 childcare places and 760 out of school hours care places
- Maintains a website with over 2,700,000 page views each year
- Undertakes 616 inspections of registered premises a year (including food shops, tattoo parlours, etc)
- Services 73,000 waste bins (garbage, recycling and green)
- Picks up 38,300 tonnes of garbage or 199kg for every resident and 19,800 tonnes of material for recycling every year or 103kg for every resident

Some of Council's key achievements over the last six months detailed in the report are:

Community

- Inner West's multi-agency approach to addressing homelessness won the NSW Local Government Excellence Award for Community Partnerships and Collaboration
- Delivered our program of flagship community events including in this half ANZAC Day, Australia Day, Celebrate 2044, EDGE Inner West, Perfect Match and more
- Our local libraries and history services continued their great work with regular programs and services - and June saw a milestone completion of the Marrickville Library and Pavilion, set to open in August 2019

Infrastructure

- Local Route 18 Cycleway Marrickville to Dulwich Hill Station completed
- New pedestrian/cycle bridge constructed at Chester Street Annandale
- New sporting grounds and facilities unveiled at Waterfront Drive, Callan Park including field lighting, irrigation, sub-surface drainage, regrading, new turf, cricket wicket and cricket net and new fencing
- New shade sails for 13 of our local parks and playgrounds, creating healthier, happier spaces for children, families and park users

Environment

- New St Peters Community Recycling Centre opened in June 2019 allowing residents to drop off tricky waste
- Climate Emergency response: Zero Waste Strategy and Pathway to Zero Emissions Community plan underway
- Thousands of community members accessed workshops, services or programs run by the Green Living Centre, and 189 people attended urban ecology workshops including water sensitive urban design, rainwater harvesting and sustainable home tours

Planning

Substantial progress has been made on Inner West's first LEP. This important
document will guide future development of the area. In this half we've delivered two
key strategies that will inform the LEP - the Housing Strategy and Integrated
Transport Strategy.

Budget

Council exceeded its \$5.5 million savings target in the 2018/19 year and for 2019/20 has adopted a budget and new operational Plan focused on saving ratepayers money and increased investment in fixing ageing infrastructure. The new budget established a \$10 million savings target. I look forward to reporting on progress in my next report in February 2020.

About the Operational Plan and this report

Operational Plan

Council prepares an Operational Plan and Budget each year in response to changing community needs and expectations. The report details the actions that Council will undertake each financial year to achieve its longer-term strategic goals, outlined in the Community Strategic Plan and scheduled in Council's four-year Delivery Program. Council is currently delivering on the *Operational Plan and Budget 2018/19*.

This report

Council produces half-yearly progress reports to provide a snapshot on progress made against actions in the adopted annual Operational Plan.

This report outlines Council's progress on the actions in the Operational Plan 2018/19 between 1 January and 30 July 2019 (the second half of the financial year), as well as the status of each action at the end of that period. At the date of publication, these actions may have progressed further than indicated in this review. This progress will be reported in future reporting periods. The report does not detail Council's annual KPI updates, which are undergoing finalisation (and audit where necessary) to be published in Council's Annual Report in November 2019.

Council's half-yearly progress reports are prepared in accordance with s404(5) of the Local Government Act and the NSW Office of Local Government's Integrated Planning and Reporting (IP&R) guidelines.




Figure 2 Action Status Snapshot for all action




Figure 3. Service Area Snapshot: Aquatic Services




Figure 4. Service Area Snapshot: Children and Family Services




Figure 5. Service Area Snapshot: Community Events




Figure 6 Service Area Snapshot: Community Services and Culture




Figure 7: Service Area Snapshot: Development Assessment




Figure 8 Service Area Snapshot Environment and Sustainability




Figure 9 Service Area Snapshot: Footpaths, Roads, Traffic and Stormwater




Figure 10 Service Area Snapshot: Library and History Services




Figure 11 Service Area Snapshot: Regulatory Services




Figure 12 Service Area Snapshot: Resource Recovery




Figure 13 Service Area Snapshot: Strategic Planning




Figure 14 Service Area Snapshot: Trees, Parks and Streetscapes




Figure 15 Service Area Snapshot: Corporate Support
