Intersection Development - Kegworth St and Tebbutt St, Leichhardt - Kerb Extensions and Garden Beds

Council is proposing to upgrade the existing intersection of Kegworth Street, Leichhardt by constructing landscaped kerb extensions (and narrowing the road pavement) at its intersection with Tebbutt Street. The works aims to improve pedestrian safety by narrowing the width of road to be crossed and slow traffic as they enter the street.

The Plan

The following works are proposed and are illustrated on the attached plans:

- Construct landscaped kerb extensions either side of Kegworth Street at its intersection with Tebbutt Street,
- Provide native plants/grasses landscaping within the new kerb extensions,
- Construct two new concrete kerb ramps and footpath approaches within the kerb extensions to allow pedestrian access,
- Reconstruct some of the concrete footpaths, kerb and guttering,
- Provide new road line markings, shown on the plans.

Please refer to the attached Consultation Plans (Plan No.10184) which illustrates the proposed works.

Parking changes:

This proposal does not change any of the existing parking arrangements in Kegworth Street or Tebbutt Street. Therefore, there will be NO LOSS of parking spaces resulting from the proposed works.

What happens next?

Council has not yet made any commitment to change the traffic arrangements in the street. A report, together with the community's comments and this proposal, will be considered by Council's Local Traffic Committee at its meeting on Monday, 7 February 2022. The Committee will make recommendations for Council to consider at the Council meeting on Tuesday 22 February 2022.

Council will notify everyone who provided comments of the final decision.

When is the work planned?

These works are expected to be undertaken during the 2021/2022 financial year, subject to the outcome of this community engagement, final approvals, and budget allocations. No firm construction date is yet available, and residents will be notified further before any work starts in the street.
