# Cameron Street, Balmain - from Mort Street to Clayton Street-Parking Improvement Works Have Your Say

Council is planning to improve the existing parking arrangements in Cameron Street, Balmain, from Mort Street to Clayton Street by adjusting the existing kerb on the southern side of the street to widen the road and forming indented parking bays. The proposed works is intended to improve pedestrian and motorist safety in the area.

#### The Plan

The following works are proposed and are illustrated on the attached plans <u>Cameron Street</u>, <u>Balmain (Plan No. 10205)</u>:

- Remove existing kerb & gutter on the southern side of the street and construct new kerb along new alignment to form indented parking bays (from A to B) as shown on attached plans,
- Construct new dish drain along alignment of removed kerb & gutter (from A to B) as shown on attached plans,
- Reconstruct existing asphalt footpath with new asphalt footpath (southern side and a portion
  of the northern side of the footpath),
- Reconstruct some damaged sections of asphalt footpath with new asphalt footpath,
- Resurface the half road width of road pavement in Cameron Street southern side only with new asphalt,
- Re-construct one driveway affected by the works (where shown on the plans).
- Reconstruct some damaged sections of kerb & gutter with new sandstone kerb & concrete gutter,
- Removing existing Parking Bay line markings within the street and footpath;
- Provide new spaces for motor bike parking on the south side (as shown on plans);
- Adjust existing No Stopping signs and remove redundant parking signage (where shown on plans).

## **Parking changes**

The realignment of the kerb on the southern side of Cameron Street will widen the road pavement which will better manage parking on this side of the street and eliminate the need to park vehicles partially onto the footpath.

It is proposed to install new "No Stopping" signs near the intersections of Clayton Street & Mort Street to facilitate the new works and to better delineate areas available for parking, whilst also installing "Motor Bike Only" signs to create 2 new spaces for Motor Bike parking. The overall outcome of these proposals is NO LOSS of existing parking spaces in Cameron Street as a result of the proposed works, please refer to the attached plans.



# Streetlighting

The existing lighting is deemed adequate and therefore there will be no changes to the existing street lighting due to the proposed works.

A report, together with the community's comments and this proposal, will be considered by Council's Local Traffic Committee at its meeting on Monday, 15 August 2022. The Committee will make recommendations for Council to consider at the Council meeting on Tuesday, 13 September 2022.

Council will notify everyone who provided comments of the final decision.

These works are expected to be undertaken during the 2022/2023 financial year, subject to the outcome of this community engagement, final approvals, and budget allocations. No firm construction date is yet available, and residents will be notified further before any work starts in the street.
