Victoria Street, Ashfield - Installation of New In-Lane Bus Stop Platform Have Your Say

Council has prepared a design plan for the installation of an in-lane bus stop platform adjacent to 90 Victoria Street, Ashfield. The intention of the proposal is to provide a bus stop facility that allows ease of safe travel between the footpath to the buses for the general public in the area.

The Plan

The following works are proposed and are illustrated on the attached plan;

Victoria Street, Ashfield (Plan No. 10215):

- construct a new concrete in-lane bus stop platform with associated tactile, seating and handrails where shown in plan
- remove existing grass verge and construct new concrete ramps for safe access to the new concrete in-lane bus stop platform where shown in plan
- provide new landscaped verge gardens where shown in plan
- construct new landscaped kerb blister where shown in plan
- reconstruct existing concrete gutter and footpath where shown in plan
- install associated signs and line markings where shown in plan
- resurface asphalt roadway where shown in plan

The above works are consistent with similarly completed works along Victoria Street in the past couple of years.

Please note that existing landscaped verge gardens will be maintained. Please refer to the attached Consultation Plan (Plan No. 10215) which illustrates the proposed works.

Parking Changes

This proposal **will not** result in the loss of any on-street parking spaces.

Streetlighting

This existing street lighting at the location is deemed adequate for the new in-lane bus stop platform. Therefore, no changes are proposed to the existing street lighting due to the works.

What Happens Next?

Council has not yet made any commitment to change the traffic arrangements in the street. A report, together with the community's comments and this proposal, will be considered by Council's Local Traffic Committee at its meeting on 19 September 2022. The Committee will make recommendations for Council to consider at the October Council meeting.

Council will notify everyone who provided comments of the final decision.

Please note that COVID restrictions may apply and limit personal attendance to the Traffic Committee (subject to restrictions in place).

When Is the Work Planned?

These works are expected to be built in the 2022/23 financial year, subject to outcome of this community engagement, final approvals and budget allocation. At this stage, a firm construction date cannot be advised and residents will be further notified before any work starts in the street.
