Guest Speakers

- Foxy Laners Artists Re: Lanterns in Fox's Lane, Ashfield <u>foxlane.lanterns@gmail.com</u> The Foxy Laners are three local artists (Selina, Alessandro & Jayanto) who have been commissioned by IWC to create a permanent art installation in Fox Lane Ashfield. ¹ They are making copper lanterns which will be lit by electricity with the thought 'THERE WILL ALWAYS BE A LIGHT ON FOR YOU'. They have approached several groups and would like to have an Aboriginal story /creative lantern to lead the lights in Fox's Lane.² There is a tight timeframe, however they would like input from the Committee. End of this month consultation finishes and will start being installed by the end of April 2021.
- Arts & Placemaking Programs Bronwyn Tuohy <u>Bronwyn.tuohy@innerwest.nsw.gov.au</u> PowerPoint³ - this was to discuss the opportunities that the Arts Department have been working on
 - Gadigal & Wangal Wayfinding Arts works 1 sculptural art piece to go into each of the Wards – Sites chosen via advice from Aboriginal Working Group and Council staff – EOI's to artists to choose site including using the Aboriginal Critical Investigation – 4 out 5 sites finished the final site - Damun (Stanmore) will be completed by Sept-Nov 2021. This is by young artist from Boomalli – Jasmin Sarin.  - Greenway this is a green corridor from Parramatta River to Cooks River via walking, bike and hiking trails. 3 of the Gadigal & Wangal Wayfinding Artworks are along this trail including the only mural in this process – Djarrawunang (Ashfield) at Cadigal Reserve. The plan is to knock a hole through and create a tunnel so that the greenway continues under the roadway.
 - Research Collaboration this links the above two projects and stakeholders from local universities who do teacher training. The project is looking at new start teachers learning to teach off country. Council, UTS, Syd Uni, & Shared Path working in collaboration with the artists to bring this program to life.

- Taverners Hill possible opportunity for some Aboriginal interpretation/artwork to go in this area and it is also a part of the Greenway missing links program. We are waiting to see on funding and other opportunities to make it happen.
- Cadigal Reserve Summer Hill this is where the mural is (see •Greenway). It was also a mentorship piece. Video link

- Explorer's Park Ashfield this park and artwork was placed in 1988, for the bicentenary. The information obtained within is very old school and very out of date.
 - Comments
 - The artwork itself is depressing as it looks as if the explorers are taking the Aboriginal people up the hill to shoot them
 - No consultation of Aboriginal peoples in 1988, not heard of
 - Need to have the signage updated to a contemporary perspective to help improve and educate
 - Need to also update signage to reflect skill and assistance of Aboriginal peoples (trackers, Scouts, guides???) the explorers wouldn't have found anything or survived

 - LGA = 1.1% First Nations
 - First Nation's people 50+ as aged due to the compounded health issues
 - Overall objective of the Plan 'how to age and participate in the community.' How to make all peoples healthier'
 - Comments
 - Street seats, particularly the one that was outside Alfred Imaging in Liverpool Road, need to be maintained
 - More seats and chairs and resting places are required in the public domain. Also, simple things like a place to hold onto the wall and rest can be very useful.
 - More disability accessible parking is required in the LGA, along with more parking for buses as shopping centres
 - Disability accessible parking is required outside doctors' surgeries
 - Alex Trevillion Plaza in Marrickville is an important meeting place for elders and the upgrade that is underway is supported
 - Getting out to meet other people, and finding and enjoying the company of others, is critically important for elders maintaining their wellbeing. With the rise of shopping centres and the decline of main streets, social opportunities are lost or diminished, and purposeful replacements are required

- Footpaths are critically important for navigation for those with mobility impairment and for wheelchairs and walkers, this includes particularly street crossings that are accessible. Uneven tiles and slippery surfaces are dangerous. Hercules Street Ashfield is slippery, uneven and people prefer to walk up the tarmac with the traffic than face the footpath. Stairs and ramp access also need careful attention. Basically outdoor and public domain spaces need to be deigned with frail elders needs in mind, and then everyone can be included.
- Poor accessibility in the public domain stops people from leaving home, is isolating and causes a decline in wellbeing and mental health. People experience long and difficult recovery from falls, and falls need to be avoided. Once someone falls, they are much less likely to leave home again or be more reluctant to do so. Fear of falling is a mind and confidence killer.
- Elders need to be engaged in the design of local places, experts don't know what is needed and don't have to live with poorly designed places. The former precinct committees of Leichhardt gave a lot of positive priority to the needs of people with increasing impairment or mobility
- Community transport is critically important but it is to expensive, difficult to access and not flexible enough (transport should come to the person, not require the person to struggle to a stop than might not be near their home). Council sponsored or delivered on-demand transport would be ideal. Norton Street Plaza is particularly difficult to get to. It maybe that there are employment opportunities for Aboriginal people in driving council or community buses, which would enable culturally sensitive transport to be provided.
- Home visits by volunteers to elders are valuable, it enables people to keep feeling connects to their communities and younger people.
- Recognition of Elders seems to have been forgotten, programming in art and culture, and Welcome to Country is a way of including Elders. The older one gets, the more wisdom one accumulates. Intergenerational participation is very important. Library days and story time led by Elders is very important.
- Digital means not accessible for Elder sin many cases and people can get the run around when they try and reach Council by phone. More information that is accessible and available is required. Targeting communication is essential.
- Health care is critically important. Accessible and free dental care is required. Not being able to smile effects mental health in a negative way. Is there a possibility that the Dental Care Program at Marrickville Community Health Centre could be expanded?
