# Item 1 Cultural Strategy

NB- presented background and questions for the MAC to consider and respond to in relation to Council developing a 10-year Cultural Strategy –with a 4 year action plan. **WHAT CAN COUNCIL DO TO SUPPORT CULTURE?** 

Some key points included;

Explore models for togetherness/ intersectionality. Provide triggers for culture to be fluid, inspire new expressions and investigations, using intersectionality.

Working from the bottom up and with young people: community led programming with Council as facilitator. Create connection to place and belonging that we can all get on board with

# WHAT ARE THE CHALLENGES FOR INNER WEST CULTURE?

Need to understand emerging practice. Understand/ review representative practice Perception that diverse groups are a problem and not an asset Intersectionality is ignored. Perception that culture is static/ fixed. Need to demonstrate value of cultural diversity.

# WHAT ARE THE STRENGTHS OF INNER WEST CULTURE?

Legacy- childcare centres first bi-cultural in Australia, Addison Rd purpose built multicultural centre. Knowledge of historical societies to form foundation of new practice Intersectionality in terms of current cultural expression e.g. LGBTIQA
