### ITEM 6 - Review of Community Strategic Plan (CSP)

On Monday 22nd of November 2021, Committee Members were forwarded the following correspondence notifying them of the current review of the existing CSP and requesting for their feedback.

Council would like to take the opportunity this Committee Meeting presents to obtain any additional feedback from members.

This additional feedback will be compiled, with member feedback sent through prior to the meeting, and used to inform current review of Council's Community Strategic Plan (2018).

With the new Council to be elected on 4 December 2021 the Inner West Community Strategic Plan, Our Inner West 2036, is under review and I'm seeking input from the Transport Advisory Committee

The Community Strategic Plan (CSP) is council's long-term plan which identifies the community's vision as well as strategies to get there. A copy of the CSP is available on Council's website. It was developed with extensive community consultation in 2017-18 and you can see a recent progress report, State of the Inner West, here. The attached flyer provides more information about the review including two upcoming community forums to be held online. This email is for Transport Advisory Committee members and you can encourage friends, neighbours and bike riders to participate at Your Say Inner West.

We need your input on whether the CSP still reflects your priorities for transport in the Inner West.

Following the CSP review a new four-year Delivery Program will be developed based on community feedback. The Delivery Program aims to translate the community goals into clear actions. You can see the existing Delivery Program <a href="here">here</a>. It's the primary reference point for all activities undertaken by council during its term of office. It allows council to determine what's achievable over the next four years, what the priorities are, and how programs will be scheduled. In April-May next year the CSP and Delivery Program will be placed on public exhibition before adoption by the new council.

#### What we need from you

The CSP has five strategic directions. We need your input on whether you think these Directions, Outcomes and Strategies are still right for our transport needs in the Inner West.
