

# GIPAA Disclosure Log of Formal Access Applications

The Government Information (Public Access) Act 2009 (GIPAA) requires Council to keep and publish a record (called its "disclosure log") that records information about access applications made to Council that Council decides to provide access (to some or all of the information applied for) if the information is information that the agency considers may be of interest to other members of the public. Council's disclosure log was prepared in accordance with sections 18(d) and 25 of the Government Information (Public Access). This disclosure log reflects applications received by the former Marrickville Council or Petersham centre of the new Inner West Council. This disclosure log is updated quarterly.
