HK: Yes we can incorporate that later, to press a button and see where you are.</p> <p>BA: What map base are you using? HK: Arctis Software/Storymap. BA: can we show a topographical map with contours etc? HK: not yet, is an added feature. Storymap is around story-telling.</p> <p>HK: I need to know from you, what you want me to include. HK: another option is nearest things, such as toilets, bus routes</p> <p>BA: can we show canopy cover or bushcare sites? HK: yes bushcare sites. BA: I think Council has tree cover imagery; we can show the GreenWay as an actual green corridor.</p> <p>NC: how about all the art, history and green items, too much all in one? Alex Lofts	<p>4.1.1 Meeting with Director Community, Ms Ruth Callaghan and officers (Nick Chapman, Jennifer Kent, Suzy Carter, Alex Lofts- not in particular order)</p> <p>4.1.2 Search for venues:</p> <ul style="list-style-type: none"> ▪ ArtSite Camperdown ▪ Petersham Town Hall ▪ other possibilities? 	<p>4.1.1. Had a meeting and tried to save the Art Prize, but Council has made a firm decision not to continue funding the GreenWay Art Prize. Council wants to fund artists rather than event costs. Shifting towards other art activities, no more art prizes in present form.</p> <p>JK: Ruth mentioned that GreenWay art component needs to be incorporated in a different way, to benefit artists.</p> <p>AL: there has been some miscommunication about not further funding the GreenWay Art Prize. There may have been an email which did not arrive.</p> <p>SC: Focus is on symposium to benefit and support local artists. Upcoming symposium in July this year.</p> <p>BA: can something arty be incorporated into the GreenWay opening? AL: yes they're looking at this.</p> <p>JK/AL: GreenWay Art Prize had focus on community, this focus may not be met with the change in policy. BA: disappointing from Council is the lack of support for community engagement. We could find a private sponsor.</p> <p>4.1.2. no longer applicable with no further funding. Council does not want to go to a commercial gallery, NC: ArtSite is not focussed on community art.</p>
Suzy Carter	<p>4.2.1 Improving dog on/off leash signage In Leichhardt between Bones Cafe area and Blackmore oval.</p>	<p>4.2.1. Conflicting interest: this is supposed to be on leash area, this is dangerous. Need extra signage. BA: GW signage has gone in and includes 'dog on leash' sign. SC: let's see if it makes a difference. JK: need a dog fence.</p> <p>NC: we can get rangers around there. And this is about managing conflict, Council needs to plan for this. BA: shared path usage is not ideal, but it is managed as a recreational resource, not an active transport corridor.</p>

		<p>BA: we/Council need to get ahead of this conflict that will come with the opening of the GreenWay and the sharing of the path.</p>
<p>Bronwyn Holland</p>	<p>4.3.1 Tree clearing and fencing boundary update 1-3 Williams Pde</p>	<p>4.3.1. The 20m Tallowwood on DP 270052 land most damaged by works is not yet removed, advised this will take place early June.</p> <p>DP270052 has been waiting on confirmation of boundary and package of photos etc as basis for deciding permanent fencing. Works on south section have resumed and a GreenWay team inspected perimeter May 7 and marked a blue line 2.36 meters inside temporary fence, and so 2.36 meters closer to 3 Williams Pde. Trees adjacent to blue line have been marked with paint.</p> <p>On querying what the blue line is, we were advised to have 'low expectations'. This is already well practised.</p> <p>Privacy and Noise impacting 41/3 Thus (sic) is how close the walkway is to my bedroom! I have lost all privacy and the noise at the moment as trying to work from home, is impossible.</p> <p>Why is this happening? Indeterminacy with regard to the boundary of DP270052 on the western perimeter of the corridor for the GreenWay project has aggravated numerous issues including: the loss of original bush barrier for DP270052 by wholesale clearing; the conservation of 5 native Tallowwood trees damaged by works; the responsibility for repairs to damaged cement Sound Wall at 40% of the shared perimeter, and now, by the vexed varying location of the permanent replacement fencing to give security and screening privacy to residents of</p>

		<p>this community. Further impacts to resident rights of 'peaceful enjoyment' are posed by the apparent significant increase in the height of the GreenWay platform in this south section from plan documents.</p> <p>This demonstrates beyond doubt the deficit in genuine community consultation and engaging with resident concerns about conservation of canopy and impacts on security, privacy, noise and their mitigation. This should have preceded and informed the planning and design process with any of the inevitable variations that arise. Adhering to the intention of this requirement under the law would have averted the compounding shock of so many externalised costs onto this GreenWay 'host community'.</p> <p>Action item: BH to send email to council to ask clarification about blue line.</p>

BA: would be good to get community involved, and Forum involved too, Action item: AL to approach Mayor.</p> <p>4.4.4. Needs coordination, maybe approach Mayor? AL: LEP submission could also work.</p> <p>4.4.5. BA to email Magda and submit Council request online.</p>

	<p>4.4.7 Report from the Inner West “Shifting Gears: GreenWay & Beyond” (mode shift forum)</p>	<p>4.4.6. Shipping containers and racks now in place –consultation promised but lacking. Action item: BA/AL to email Simone Plummer. Maybe the bushcare teams can get involved in this as well, e.g. Fountain Grass is present there. BA to contact dragon boat group? This can be part of consultation. AL: mention this in email to Simone Plummer.</p> <p>Broader issue of Canal Rd route being downplayed/ignored as part of the GreenWay works. Also, we need recognition that this area is part of GreenWay route; the boats are long and can close off the path from cyclists/pedestrians. AL and BA to work together to express concern about the risk to Simone Plummer.</p> <p>4.4.7 Forum held 16 May this year. Forum was going to come up with vision, targets and actions. A very tentative start was made with this. No senior Council staff was in attendance. No clear outcomes or summary items for actions. Consultant’s report will be sent to Ken Welsh who will take it to Council to be incorporated in 2026 strategies. An online forum may be established.</p>
