### The Inner West Planning Panel resolved as follows:

1. THAT it supports the Planning Proposal prepared by Inner West Council.

That the draft Planning Proposal prepared by Council officers dated August 2023 to amend Schedule 5 and the Heritage Map of the *Inner West Local Environmental Plan 2022* has sufficient strategic and site-specific merit to be submitted to the Minister for Planning and Public Spaces for a Gateway Determination in accordance with Section 3.34 of the *Environmental Planning and Assessment Act 1979*.

#### Reasons for the recommendation

#### PART A:

1. The draft Planning Proposal is consistent with, and gives effect to, the relevant strategic planning framework.

#### PART B additional notes:

The Panel recommended the following amendments to the draft Planning Proposal document:

- Table 4 Early Engagement level of support. The table should separately list the five categories of support being: very supportive, completely supportive, moderately supportive, slightly supportive, not at all supportive.
- Wording on page 36 be updated:
  Existing 'There were no issues raised in the engagement necessitating changes to the PP'.

<u>Proposed</u> – While the early engagement comments do not preclude the planning proposal from proceeding to Council for consideration, the matters raised will continue to inform the proposal as it progresses, including at Council endorsement, post-Gateway and during Statutory consultation.

Description	Council-led Planning Proposal to list 26 pubs across Inner West local government area as items of local heritage significance.
