INNER WEST COUNCIL LOCAL TRAFFIC COMMITTEE Transition meeting Agenda (Ashfield)

The Inner West Council Local Traffic Committee has no decision-making powers and is primarily a technical review committee. It only advises the Council administrator on matters for which the Council has delegated authority. The Committee operates under Roads and Maritime Services 'A guide to the delegation to councils for the regulation of traffic'. In summary:

- Roads and Maritime Services (RMS) has delegated certain aspects of the control of traffic on regional and local roads to Council. A condition of this delegation is that Council must refer all traffic related matters to the Traffic Committee prior to exercising its delegated functions.
- The four voting members on the Traffic Committee are:
 - o Council's representative (chair)
 - o RMS representative
 - o NSW Police representative for the Local Area Command containing the item.
 - o State Member of Parliament representative for the electorate containing the item.
- The meeting does not need a specific quorum, however any advice can only be returned to the Council administrator if the views of NSW Police and RMS have been obtained.
- The Local Traffic Committee transition meeting operates as a closed meeting and attendance to the meeting is via invitation only. At times interested stakeholders may address items referred to the Traffic Committee where their information adds value and does not greatly increase the time spent by the Committee on progressing the item. Interested stakeholders always have the opportunity to attend the Council meeting when the minutes of the Traffic Committee are discussed / determined.
- All formal items referred to the Traffic Committee typically have been fully investigated, consulted (if needed) and proposed actions identified.
- Where the Council administrator decides on an item contrary to the Traffic Committee recommendation, then Council must immediately advise RMS and NSW Police in writing of its decision. The RMS or NSW Police may then lodge an appeal within 14 days to the Regional Traffic Committee.
- The Council must not action any item under appeal until the matter has been determined by the Regional Traffic Committee.
