Subject: Group assessment of Interim Strategic Reference Group

SUMMARY

An evaluation of all Interim Strategic Reference Groups (SRGs) will take place during November 2017 following the election of Council in September. This evaluation will consider both process and outcomes of all eight SRGs. The results of this evaluation will be reported to Council at its December meeting.

RECOMMENDATION:

THAT members of the SRG at the 20th November meeting carry out a group assessment of the SRG's processes and outcomes and that a report of this group assessment be provided to the Communication and Engagement Coordinator.

Background

The purpose of the SRGs was to "provide feedback, guidance and recommendations to Council on specific issues, including strategic planning and policy and contribute local knowledge regarding community impacts, emerging trends, opportunities and service gaps."

The SRGs form part of a broader Community Engagement Framework which was adopted by Council in June 2017. The SRGs are one form of engagement which ensures community input on higher level strategic issues across the Inner West.

A decision was made to review the SRGs following the return of the elected Council in September. This evaluation will take place during November 2017.

It is recommended that part of this evaluation include a group assessment of the SRG by members at the 20th November meeting and that questions for group consideration include:

- 1. What aspects of the SRG have worked well? What has not worked so well?
- 2. The purpose of this SRG was to [read from your SRG's Terms of Reference]. To what extent did the SRG achieve our purpose?
- 3. What is our SRG's most significant piece of work? Why?
- 4. Thinking about options for the future, what are your thoughts on how the SRGs could evolve? Are there other models we could consider?
- 5. Apart from SRGs, what else should Council focus on to increase satisfaction with community engagement and achieve a strong community voice in decision making?

The results of the evaluation of all Interim SRGs will be reported to Council at its December 2017 meeting.
