SUMMARY

Robust input from the Strategic Reference Groups (SRGs) is a vital component of the development of the Inner West's first Community Strategic Plan (CSP). Input to the CSP is one of the core roles of the SRGs. This agenda item has been relisted to engage members in a workshop at the meeting on 26 June to develop a submission on the draft Community Strategic Plan.

RECOMMENDATION:

THAT the Housing and Affordability Strategic Reference Group contribute to a submission on the draft Community Strategic Plan, Vision, issues and priorities, to be finalised and lodged by 9 July 2017.

Background

The Community Strategic Plan (CSP) is the most important plan that sits above all of Council's other plans and policies. The CSP identifies the community's main priorities and aspirations for the future, and plans strategies to achieve them. It takes into account the issues and pressures affecting the community, and the level of resources that will realistically be available.

While Council is responsible for managing the planning process on behalf of the Inner West, delivery of the plan's long-term outcomes relies on strong partnerships, including with State agencies, community groups and the wider community. A successful CSP is one in which the whole community feels ownership.

The CSP will:

- identify the community's main priorities
- provide a vision and plan for the whole Inner West community
- set goals for the future
- outlines strategies and actions to achieve these goals
- inform Council's long term planning and resourcing

The Inner West's CSP will be based on principles of:

- social justice (equity, access, rights and participation)
- ecologically sustainable development

Reference Group Input and Submission

The SRG can contribute to the CSP by:



- participating in the workshop at the 26 June meeting and answering questions raised in the Issues Paper and/or participating in a conversation relevant to the area of interest or expertise of the SRG
- Commenting on the Draft CSP at review stage (from August 2017 approximately)

Community Strategic Plan Issues Paper

An Issues Paper has been prepared by Council's Corporate Strategic Planning and Community Engagement team. A copy of this Issues Paper is available on the Housing and Affordability SRG webpage.

The paper has been developed to help inform discussion and provides a high-level context of the current priorities, opportunities and challenges facing the Inner West.
