Consensus on support for the Draft Terms of Reference

Recommendation:

The Reference Group agreed that regardless of meeting the quorum numbers any recommendations made by the Planning and Heritage Strategic Reference Group would be forwarded to the Group Manager for consideration.

Other Points:

Inner West Council - Vision and Priorities Item 7.

Recommendation:

The Reference Group recommended changes to the Vision Statement in Draft Statement of Vision and Priorities as follows:

o We are the Inner West, with rich cultures, heritage and history. We acknowledge and respect the land of the Cadigal and Wangal peoples. Together we are a diverse and inclusive community. We are a creative and vibrant community united in our desire to plan a great future for all who live and do business here.

Recommendation:

The Reference Group agreed that the emphasis in Priority 1 needed to be on both industrial and employment generating lands, as follows:

"Retaining diversity of industrial lands and employment generating land uses" instead of "Retaining industrial land"

Recommendation:

The Reference Group agreed that the final bullet point in Priority 4 required rewording to:

o Conserve our historic places as integral to sustainability and resilience.

Other Points:

- The Reference Group raised concern that Heritage is not one of the 8 high level priorities.
- The Reference Group considered Priority 5 of "one council" to be a bit of "window dressing" and shouldn't mean we can't tell the different stories of each former council areas.
- The Reference Group identified the need for a Vision statement to address Aboriginal heritage as well as post-settlement heritage and history.
- The Reference Group noted that the Vision Statement lacked a reference to the environment, however it was agreed that this matter was best addressed by the Environmental Strategic Reference Group.
- The Reference Group queried the selection of major projects in IWC area under Priority 7 -Yasmar Estate, WestConnex, Callan Park; why not Cooks River?

Item 9 **Update from Planning Staff**

Recommendation:

Planning staff to issue a circular to the Reference Group members prior to next meeting with a summary of the major strategic planning and heritage projects currently in progress.

Other Points:

 It was submitted that a State nomination should be pursued for the Haberfield Conservation Area and that this is supported for National listing. This was taken on notice - to be discussed with a representative from the former Ashfield Council prior to the next meeting.

Recommendation:

That concerns relating to the organisation structure, in particular the separation into different divisions of the strategic planning and statutory planning sections be brought to the attention to the Administrator and the Interim GM

John Stamolis (former Leichhardt Councillor) raised concern that heritage may be "overlooked" given this was primarily a planning reference group. It was noted that group members had a good mix of both heritage and planning expertise and that the issue be re-visited following a couple of meetings to ensure heritage was not being "overlooked".
