Regional Significance













- Callan Park is one of the largest and most regionally significant public facilities in Sydney's Inner West.
- Over 60 hectares
- Enlightened hospital for the insane in 1885
- Callan Park is a State Heritage item



Ownership

- Site is owned by NSW Health
- Prior to May 2015 responsibility for management lay with SHFA
- In 2015, responsibility for Callan Park transferred to the Minister for the Environment.
- Site was assigned to the Office of Environment and Heritage (OEH).
 OEH responsible for grounds maintenance and security.



Legislative Background

Callan Park (Special Provisions) Act 2002

- Key objectives of the Act
 - Public ownership
 - Preservation of the areas of open space
 - Public access to open space
 - Preserve heritage significance
 - Impose appropriate controls on future development
- The Minister of Planning may grant leases, licences for the use of buildings or land within the park.



Planning Framework

- Callan Park Act 2002 'freezes' the planning legislation that was in force at the time of commencement of the Act
- Frozen legislation means:
 - SEPP 56 applies requirement for a master plan to be prepared before consent can be granted
 - Exempt or complying development does not apply
- Council is the consent authority
- All DAs require approval from NSW Heritage Office



Planning Framework

- Limits land uses to health facilities and educational (not schools) or community facilities
- Buildings must not be erected outside the footprints or building envelopes of the buildings
- Site is also known to be contaminated and reports required with each DA that may involve soil disturbance



Recent Council Improvements

- Council improvements to community facilities in the park:
 - Two sporting grounds Balmain Road and Glover Street.
 - Community and Refugee Welcome Centre
 - Public toilets at Balmain Rd Sporting Ground
- Waterfront Drive DA approval:
 - New lights 2017/2018
 - Resurfacing playing fields, drainage, irrigation 2018/2019

INNER WEST COUNCIL Key Current Issues - Master Planning

- State government is responsible for master planning
- Former Leichhardt Council recognised the need
- In 2010 extensive community consultation
- In November 2011 Leichhardt Council and the Friends of Callan Park formally presented the Draft Callan Park Master Plan to the Minister for Planning



- No formal adoption of the draft master plan by the NSW Government.
- OEH preparing a Landscape Structure Plan



Key current issues – Trust

Council advocates a Trust model

Trust governance model to oversee complexity of site

Trustee membership to reflect complex issues



Key current issues – Other Council Initiatives

- Recent refusal by the State government for Council initiatives on behalf of the Inner West community:
 - Regional Skate Park
 - Balmain Para-Rowing
 - Men's Shed at the Electrical Store



Key current issues

- Sydney College of the arts vacating Kirkbride (planned departure in 2019)
- Limited State Government funding for the site



- Original proposal adjacent to Balmain Road Sporting Ground
- DA withdrawn
