## Item 1 Project Timeline

- initial survey and geotechnical investigations until late August 2016
- community consultation to commence late August/early September 2016
- preliminary draft alignment and portal locations before end of 2016
- Environmental Impact Statement exhibition first quarter of 2017
- Environmental Impact Statement determination late 2017
- construction to commence late 2018 or early 2019

## Item 2 <u>Community Consultation</u>

- The community consultation program will be in several stages, initially with a number of smaller events being used as "Ideas Sessions" to inform the environmental impact assessment process;
- The sessions are likely to commence in late August/early September 2016 and will include meetings in Balmain, Leichhardt, Five Dock and Camperdown;
- In these sessions only limited information will be available on alignment, portals, ventilation locations etc;
- It is anticipated that follow-up consultation sessions will be held toward the end of 2016; prior to finalisation of the Environmental Impact Assessment
- Sydney Motorway Corporation offered to brief Council's Local Representative Advisory Committee if required (LRAC)

## Item 3 Environmental Impact Assessment (EIS)

• It is anticipated that the EIS will be exhibited early in 2017



• Council requested that the EIS exhibition not be held during the December-January school vacation period

#### Item 4 Noise Monitoring Station- Hucheson Street

- Council had previously expressed concern regarding proximity of the proposed noise monitoring station to the light rail maintenance facility (currently being constructed);
- To ensure that construction noise does not create a false, higher than normal, ambient noise baseline SMC will include on-site manned monitoring to identify any temporary noise that may be recorded

#### Item 5 Access to Open Space

- SMC requested an update on the availability of Algie Park and Blackmore Oval for geotechnical investigation;
- Council undertook to determine appropriate action in relation to these two locations.
